The main factors have been the continuously increasing tuition fees and stronger New Zealand dollar, students' perception that New Zealand degrees are less prestigious than others and a difficult job market in China. Paradoxically, Chinese students have also been more likely to remain in New Zealand. by Limin BAI
The VIP-Room Contractual System and Macao's Traditional Casino Industry Macao has handled VIP players, or those who are willing to put substantial amounts of money at risk, differently from other major casino centres in the world. The VIP rooms have become the dominant source of revenue in Macao's casinos since the 1980s. Job Search Channels and Educational Level in China: Testing the Screening Hypothesis Though China has a vast job market, young people often have difficulty finding suitable employment. This article tests the screening hypothesis for the graduate job market by investigating the relationship among job search channels, educational level and the results of job searches. The effect of educational background on the probabilities of obtaining a job does not change with different search channels.

Public Goods Provision and Rural Governance in China "Grassroots democracy" makes administrations more public service-oriented at the village level. As for governance at the county level, increases in intergovernmental fiscal transfers to county budgets do not necessarily improve the provision of rural public goods. Moreover, calls for retrenchment tend to affect public servants, such as teachers and medical workers working in rural areas, more than administrative officials. by SATO Hiroshi
The Role of the Agricultural and Industrial Sectors in China's Economic Growth: Are They Twin Brothers? While technological progress appears to be the most important determinant in China's agricultural sector, foreign direct investment appears to be most important in its industrial sector. Growth in the agricultural sector tends to have a significantly positive effect on growth in the industrial sector. Chinese Success with FDI: Lessons for India China and India are the two fastest growing economies of the world. Both are not only challenging the world order but are also virtually redefining global parameters of growth. However, their growth models are entirely different. He has also written many articles in internationally refereed journals and book chapters in English language books, as well as edited or co-edited many volumes in Chinese. He is the editor of the China Policy Series (Routledge) and co-edits the Series on Contemporary China (World Scientific).
